February 8, 2021

1. The District ran a total of 43 calls for the month of January 2021.

2. Projects currently
- ISO rating – We have submitted the last of the paperwork to ISO. Just waiting for the response.
 - We have finalized the build for the new Brush Rig. – Talked with the vendor last week and we are still on schedule for a June 2021 completion date. Finalizing the funding piece now so we will be ready.
 - The correct hydraulic reels have been installed in the two engines. We are currently working with the vendor to get the correct 4” hose.
3. Grants
- AFG – SCBA’s – The new SCBA’s are here, and were placed in service on January 21, 2021
 - Safer Act – The 6th request has been submitted.
 - I re-submitted an AFG-S grant last week for just over \$37,000 for supplies used for the COVID-19 event.
 - The new AFG application period has opened. Working on that application with the plan of applying for, 22 sets of Turnouts, 22 additional SCBA face masks, 9 Triband mobile radios and 20 pagers.
 - We did receive a 50/50 matching grant from SDAO for Security to purchase more camera’s to be installed in the building next door.
 - Will be working with Murray Paolo on the Homeland Security Grant for Radios.

- g. Looking at the Fire House Subs Grant to help replace some of the District's AED's
- 4. We are still waiting on reimbursement from the State for the Conflagration Fires in the amount of \$162,962.02.
- 5. On January 24-25, 2021 we did have a Fatal Fire in the District. On January 28, 2021 we did a debriefing and on January 29, 2021 we had the Washington County Sheriff Critical Incident Debriefing team here and we hosted that and invited everyone that was involved with this fire to attend. We had approximately 30 to 35 people in attendance. We continue to check on everyone.
- 6. On January 30 and 31 we sent 4 people to a S- Chainsaw Class. See the attached letter that I received from the instructor.

- 7. On January 22, 2021 I picked up the Newberg Hazmat Trailer from TVF&R. That trailer now belongs to Yamhill Fire Protection District. It is equipped with a Generator, Portable Hot Water Heater, and a portable Heater along with other Hazmat equipment. The plan is to repurpose this into Rehab 4 which along with the Hazmat equipment we will add the equipment that we have for an Air Trailer. A group is working on a layout and plans at this time.
- 8. On Thursday 2-4-2021 I was notified by ODF of a Type 3 Brush rig that was available thru the FEPP program. I have talked with them some and have put are name in as a possible candidate for this rig.

Attached are pictures of a FEPP Type 3 engine that is full of life. 1000 gallons fully operational with two reels, good rubber AT, 2WD duals, 65K ODO, diesel. I do not have anyone currently on the request for this type of engine. Please check with your folks to see if we can place this clean Type 3 engine. Let me know soon as possible if you have an interested Department.
